A WORD FROM OUR EXECUTIVE DIRECTOR

As we look in the rear view mirror at the hurdles of 2021 and the response of the Action Center's front line team, the story is quite dramatic. As COVID continued to challenge our country, our community our neighbors with economic uncertainty and fear for our own and our loved one's health and wellbeing, The Action Center found ourselves standing strong, working to be a pillar of consistency and support.

Who could have guessed that as we were closing out 2021 COVID would continue to require that The Action Center distribute food through a drive-thru/ walk-up distribution. That our staff would be working hard to connect personally with our community through the window of a car, over the phone, and online. Providing unprecedented amounts of food, clothing, rent and utility assistance and emergency financial support, and connections to critical resources that would help to stabilize thousands and thousands of families in our community.

The continued economic fallout from the pandemic disproportionately impacted the most vulnerable in our communities. With increased cost of living in Denver Metro and the accompanying inflation, our community would continue to rely on us as a safety net.

In 2021 our participants would climb to record numbers yet again. With over 32,000 visits to our grocery, distributing close to 3,000,000 lbs. of food, and over \$2,200,000 of rent assistance, we have seen and responded to new individuals and families each week needing support. And, in the midst of these challenges The Action Center not only rose to the challenge but found ways to grow, shift and improve our responsiveness and accessibility to our community by strengthening, growing

and diversifying our team. We added four bilingual team members from the Latin/Hispanic community, we added an outreach manager to bring our services beyond our own walls, and we grew our housing support with a housing specialist.

I am proud of our team's strength, resilience and continued resolve to support our neighbors in need this year, and I am proud of the ways we have pushed ourselves to stretch and grow in the midst of the challenge. We could not have been there in strength for our neighbors, if you had not been there for us. We are so and

grateful for kindness, unwavering support and generosity. Thank you!

WHAT WE DO

The Action Center works hard to be one of the most comprehensive human service providers in Jefferson County.

The agency works to respond to participant needs in a compassionate way and helps connect them to the resources they need to stabilize their lives.

Providing 10+ programs in FY21, with over 8 Community Partnerships, the Action Center has continued to meet the need of our community in a unique and thoughtful manner.

FY21 saw the Action Center continue work within the confines of COVID-19 restrictions while experiencing increased demand from our neighbors in need.

For instance, the agency's Rent/Mortgage assistance grew from \$299,827 in FY20 to over \$2,278,805 in FY21. The average visits per day ballooned from 60 households in FY19 to 158 household visits per day in FY21.


With the support from the community, The Action Center was able to ensure that our neighbors in need had consistent and sustainable access to the agency's many resources.





"I just wanted to reach out and thank you and the team at Action Center! This year has been, hands down, the most upside down year of mine, and my families life. Between losing our jobs, moving across states early in the pandemic, trying to find housing with no proof of income, and many other hurdles along the way, we have always found a way to keep our heads above the water. I've always considered us a successful and incredibly motivated family. My husband was Vice President of sales for a golf club manufacturer in southern CA and I was a previous Law Enforcement Park Ranger with a bachelors in Parks and Resource Management, but, despite all of the government "kick backs" we still struggled to stay ahead of the game. Our 3 children are our world and the older 2 just started school this year at Slater Elementary, which is where I learned about your services. We've never turned to help from others or even community support, but when we were approached in such a welcoming and friendly manner from the folks working for the Action Center, it was very humbling, comforting, and offered a bit of financial relief. The staff is always so non-judgmental! I've never pictured myself accepting help like this. I just wanted to thank you, from the bottom of my heart, for all of the help, support, and information you have provided. It's clear that you can't place a "look" on those who are struggling in life. I'm confident in our will to survive,

and I know we will make it through this, but your team/organization is helping us through! I don't know if you hear it enough, but thank you for the help and the resources you have provided to me and my family! We are forever grateful, humbled, and thankful."
